**Rental Contract**

Application is hereby made for the rental of the memorial firemen's grounds, located at 15 Sandhill Rd (Rt 62) Gowanda, NY 14070 and all facilities, kitchen, pavilion, etc, from the Gowanda Volunteer Fire Company Inc. herein referred to as the "Renters" for \_\_\_\_\_(date) for the purpose of \_\_\_\_\_. In consideration for the use on said date for said purpose herein after called the "Rentee" agrees to pay the renters, the rental fee in the sum of \$ \_\_\_\_\_, as full payment, no later than \_\_\_\_\_(date).

**Upon signing and return of this contract, to reserve the above date, a security deposit of one hundred dollars (\$100) must accompany the signed contract received by the Renters.**

The party or group engaging the premises agree that they will be responsible for any damages inflicted upon the Renters property by its members or guests during the time for which they have engaged the above said property, and they will accept the estimate of damage offered by the Renters officer's, and make restitution for said damage in addition to the agreed upon rental fee. The Rentee agrees to pay for or replace any articles borrowed from the Renters during the event.

The Rentee further agrees to thoroughly clean up the rented facilities of paper, boxes, liter, and debris of all kinds; **Picking up all garbage on the premises**, and leave the premises in a clean and orderly condition on the day of the rental. The Renter will provide trash bags which when filled, will be secured and placed in the dumpster on the premises. In the event that the premises are not left in a clean and orderly condition, the Rentee will pay the Renters an amount determined by the Renters Board of Directors which will determined by the amount of time spent and the number of people required to do the cleanup. Upon inspection of the premises the evening of the rental, or in daylight, the security deposit minus any agreed upon damages or incurred costs. The deposit is non-refundable if you cancel and the Renter is unable to rent the premises on that date.

It is understood by the Rentee that any officer of the Renters shall have privilege and the right to be on the premises for purpose of overseeing the use during the time and date of the rental.

The following must be complied with the Rentee upon ending the event and leaving the premises. Electric lights shut off, stove and water turned off, doors closed and locked, check toilets to be sure they are flushed and tank water is not running, floors swept, tables and kitchen areas wiped clean. All garbage cleaned up and secured in the kitchen, picnic tables returned to the pavilion, etc.

The Rentee agrees that it will hold the Renters harmless against, and not responsible for any all will claims, damages, or causes of action for damages arising from the use of the premises, and will indemnify the Renters for all such suits, orders or judgements brought on account of injuries to persons or property sustained by the use of the premises.

I have read the foregoing and understand that signing this rental agreement, will make it a legal binding contract in the State of New York. However, under special circumstances agreed to by the Board of Directors of the Renters, this agreement and/or fees may be canceled at a later date.
